- Licensure as a physician pursuant to Chapter 458, Florida Statutes; licensure as an osteopathic physician pursuant to Chapter 459, Florida Statutes; or a current Public Health Certificate issued by the Florida Board of Medical Examiners pursuant to Section 458.316, Florida Statutes
- Responsible work experience in public health or in a correctional facility
- Must maintain an active Drug Enforcement Agency (DEA) registration
- Must possess and maintain a valid Florida Driver's License.

Knowledge, Skills, Abilities & Other

Regular and prompt attendance is mandatory in the performance of an employee's duties for this position, to include scheduled work hours, and required training activities, calls for mandatory overtime needs and calls for service during times of an emergency.

Knowledge of information and techniques needed to rehabilitate physical and mental ailments and methods to evaluate treatment. Knowledge of the principles and processes involved in strategic planning, resource allocations, manpower allocations and leadership techniques. Knowledge of public health administration.

WORKING CONDITIONS

The work environment is an office/medical clinic within the confines of a correctional facility. Work is generally performed in a sedentary or standing position. There is direct inmate contact. The position generally works during normal business hours, although the incumbent must be available on a flexible schedule and be available for after hour's on-call duty to handle emergency situations.

PHYSICAL ATTRIBUTES REQUIREMENTS

Mobility-Mostly sedentary work but some standing and walking; constant use of a computer

Lifting-Able to lift at least 25 pounds

Visual-Constant overall vision; constant eye-hand coordination; frequent reading/close-up work

Dexterity-Frequent repetitive motion and reaching
